SPECIFICATIONS

Wood:

New wooden, teak furniture has natural colour differences found in the freshly cut wood. Once the furniture has been exposed to the sun, these colour differences will even out. As a natural part of the aging process, the surface of teak will change when first being exposed to rain; this is the first stage of a process of wood that ages with beauty.

Metal:

Aluminium is a lightweight, non-corrosive and recyclable metal that is both strong and flexible. Powder coating is used as a metal finish on the aluminium surface. The dry coating process whereby pigments are applied to metal surfaces is cured with heat for a durable, protective finish. Fritz Hansen uses powder coating on chairs, tables, shelving systems and other furniture items.

Stainless steel is a durable, corrosion-resistant metal known for its strength and flexibility, making it an ideal choice for outdoor furniture. A powder coating is applied to the stainless-steel surface through a dry coating process, where pigments are adhered to the metal with heat, creating a long-lasting, protective finish.

Textile:

Sling textile is a water-repellent textile with high UV resistance, which makes it a good choice for outdoor use. It is made of 100% Woven Vinyl-Coated Polyester and is therefore very durable in changing summer weather and keeps the furniture seat and back from sagging.

SPECIFICATIONS*

The quickdry outdoor foam provides a firm and comfortable seat that retains its shape year after year. The open-cell structure allows both water and air to pass through ensuring the cushion dries exceptionally quickly, even after a heavy downpour. To ensure cushions remain beautiful over time, it is good practice to avoid them being left wet for prolonged periods, e.g., by turning them upright to let water run off or storing them in a dry environment.

IMPORTANT NOTE!

Under current UK law, Fritz Hansen is not able to provide outdoor cushions and pillows with the same filling as the regular collection. We still offer cushions and pillows in an outdoor textile with weather-proof properties, but the filling is not weatherproof due to stringent (indoor) fire regulations. We therefore recommend that you bring cushions and pillows indoors in heavy rain and when they are not in use.

The FR cold foam provides a firm and comfortable seat that retains its shape year after year. The FR cold foam is not weather resistant, and therefore it is recommended to store the cushions indoor when not in use and during heavy downpour. To ensure cushions remain beautiful over time, it is good practice to avoid them being left wet for prolonged periods, e.g., by turning them upright to let water run off or storing them in a dry environment.
